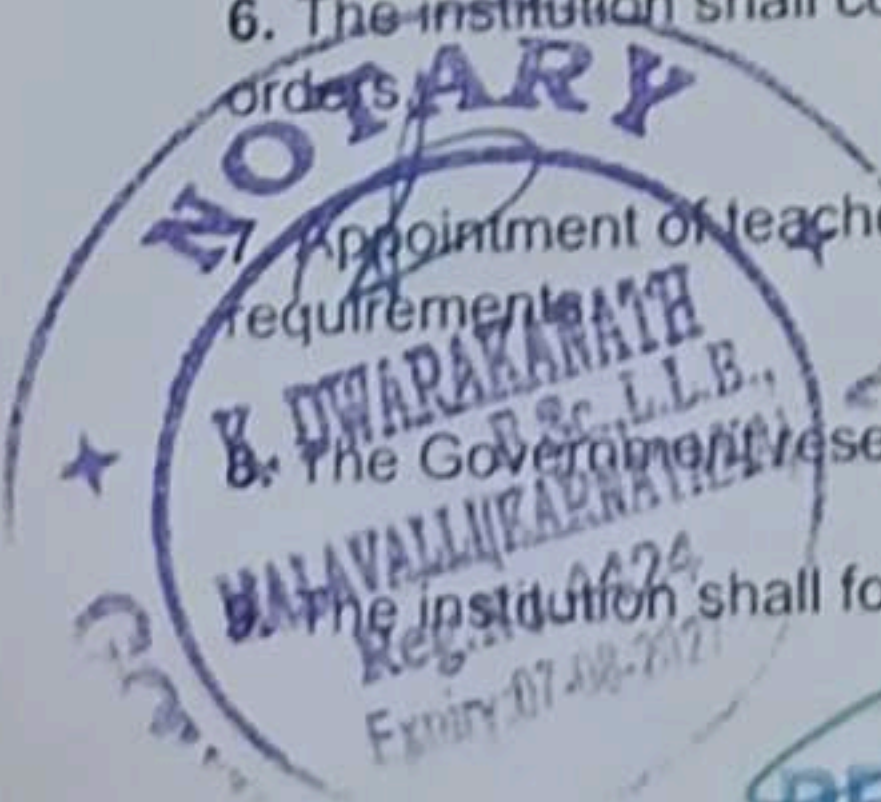
**CONDITIONS**

9. The institution shall follow all directions issued by the Department of Public Instruction from time to time.



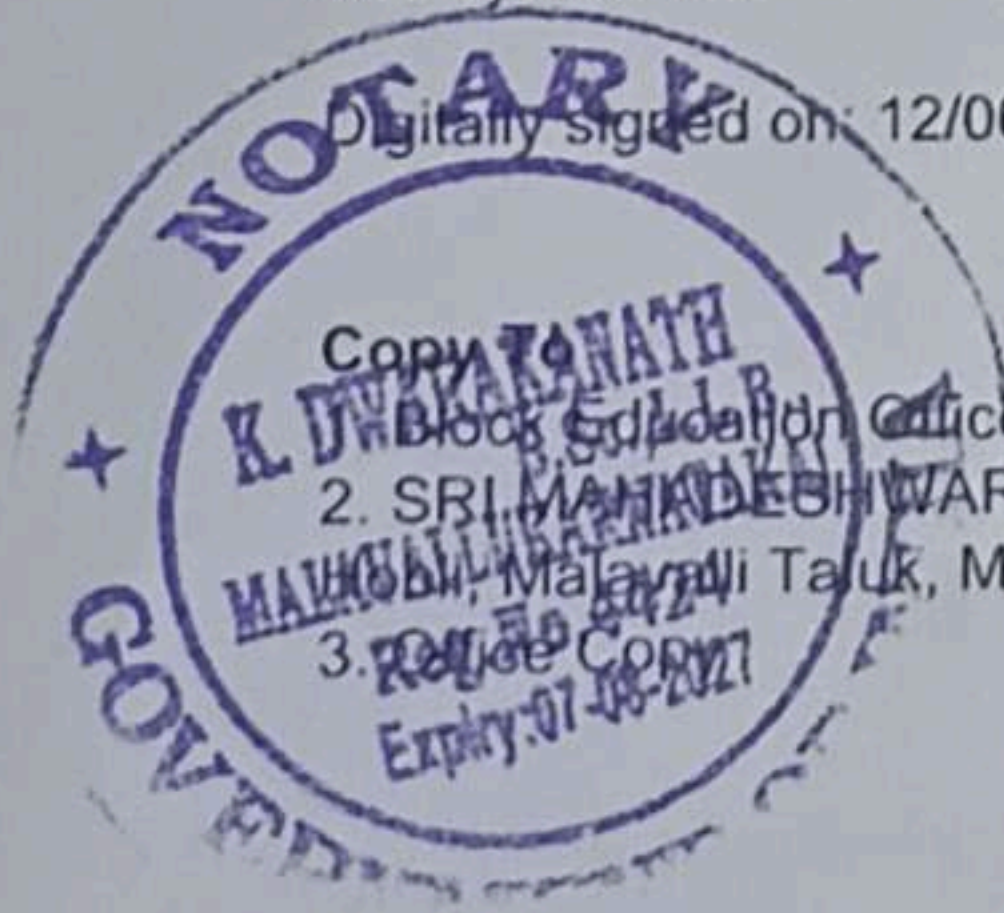
